WELCOME

Henrik Skouby President of the British Allied Trades Federation welcomed members and guests to the meeting.

The President declared the meeting open.

NOTICE OF MEETING

The president explained that the business of this meeting as set out in the notice of meeting which was circulated on 10th May and can be found on the BATF and NAJ websites.

APOLOGIES

The President proposed that the apologies, being too numerous to read out, will be recorded in an annex to the minutes.

The President welcomed Gary Wroe who is the President of the National Association of Jewellers

NAJ ACTIVITY AND FORMAL BUSINESS

Gary gave apologies Heather Callaway and read her speech as outgoing chair and welcomed Adam Jacobs as the incoming chair.

Adam (Chair) thanked Gary and confirmed Heather as the new Immediate Past Chair.

The Chair gave an overview of his plans for NAJ over the next two years.

The resolution was carried.

RE - ELECTION OF JOHN HENN AS A DIRECTOR

The President informed the meeting that notice has been received for the re-election of Mr John Henn as a director of the Federation for the period of 2024 to 2025 and this was proposed by Barry Sullivan and seconded by John Joyce.
